		The Consultant should maintain confidentiality/ absolute secrecy of the work carried out by him/ her. The Consultant shall be bound to hand-over the entire set of records of assignment to NIA before the expiry of the contract period and before the final payment is released by NIA.
		Consultant shall sign an agreement of confidentiality containing a clause on Ethics and Integrity.

15	Termination of engagement	The engagement shall automatically stand terminated at the end of the engaged period unless extended by NIA, on mutual consensus by both the parties, i.e. Consultant & NIA.  The contract may be terminated by giving fifteen days' notice by either side. In the event of pre-mature termination of contract without advance notice of 15 days, an amount of remuneration equivalent to 15 days of Consultant's remuneration shall have to be given by NIA or to NIA by the Consultant as the case may be. In the event of termination of the agreement, the remuneration will be paid on pro-rata basis as per attendance during the notice month.  Brief ground of pre-mature termination of contract of consultancy service is as under: -  (a) The Consultant/firm is unable to address the assigned work (b) Quality of the assigned works is not to the satisfaction of NIA (c) The Consultant/firm fails in timely achievement of the target as finally decided by NIA  (d) The Consultant/firm is found lacking in honesty and integrity (e) If any declaration /information furnished by wilfully suppressed any material fact(s), he/she will be liable for termination of contract including any administrative and/or legal action, as NIA may deem fit.  (f) The termination of contract must be got approved by the competent authority of NIA after obtaining proper "No Objection" and "No Dues" certificate from all officers concerned of NIA.  (g) The termination will be without prejudice to either party's rights accrued before termination.
