It is proposed to fill up one post of Statistical Assistant, a General Central Service (Group 'B') Non-Gazetted, Non-Ministerial in the Pay Matrix Level-6, Cell-1, Rs. 35,400-1,12,400/- (As per 7th CPC), at National Sugar Institute Kanpur, Ministry of Consumer Affairs, Food & Public Distribution, Department of Food & Public Distribution on deputation (including short-term contract) basis. The post of Statistical Assistant is to be filled up on deputation from amongst candidates Officials of the Central Government fulfilling the following:-

Deputation (Including Short-Term Contract):

Officers of the Central Government or State Governments or Union Territories or autonomous and statutory organisations or Public Sector Undertakings or Universities or recognized Research Institution:-

- (a)(i) Holding analogous posts on a regular basis in the parent cadre or department; or
- (ii) With six years' service in the grade rendered after appointment to the post on a regular basis in Level-5 in the pay matrix (Rs. 29,200-92,300/-) or equivalent in the parent cadre or department; and
- (b) Possessing the educational qualifications and experience prescribed as under:-

Essential:-

- (i) Bachelor's degree with statistics as one of the subjects from a recognized University or Institute;
- (ii) Two years' experience of statistical work involving collections, compilation and interpretation of statistical data.

Desirable:

Master's degree in Mathematics or Economics or Commerce (with statistics as one of the subjects) from a recognized University or Institute.

Note 1: The period of deputation including the period of deputation in another ex-cadre post held immediately preceding the appointment in the same or some other organization or department of the Central Government shall ordinarily not exceed three years.

Note 2: The maximum age limit for appointment by deputation shall be not exceeding 56 years as on the last date of receipt of applications.

For the purpose of appointment on deputation basis, the service rendered on a regular basis by an officer prior to the 1st January, 2006 or the date from which the revised pay structure based on the recommendations of the Sixth Central Pay commission has been extended shall be deemed to be service rendered in the corresponding grade pay or pay scale extended based on the recommendations of the said pay Commission except where there has been merger of more than one perrevised scale of pay into one grade with a common grade pay or pay scale and where this benefit will extend only for the post or posts for which that grade pay or pay scale is the normal replacement grade without any upgradation.

The place of posting will be National Sugar Institute, Kanpur (Uttar Pradesh) but libel to be posted anywhere in India.

No application without proper channel will be entertained.

Candidates who once apply for the post will not be allowed to withdraw their candidature later subsequently.
