Cochin Shipyard Limited (CSL), a listed premier Mini Ratna Schedule 'A' Company of Govt. of India, invites <u>online application</u> from eligible Graduate holders in Engineering, Diploma holders in Engineering who are domicile in Andaman & Nicobar Islands and passed during 2021,2022,2023,2024 & 2025, for undergoing one year Apprenticeship training under the Apprentices (Amendment) Act 1973 for CSL AN Ship Repair Unit (CANSRU), Sri Vijaya Puram.

I. <u>MINIMUM EDUCATIONAL QUALIFICATIONS:</u>

A. Category - I Graduate Apprentices:-

- A Degree in Engineering or Technology granted by a Statutory University in relevant discipline.
- A Degree in Engineering or Technology granted by an Institution empowered to grant such degree by an Act of Parliament in relevant discipline.
- Graduate examination of Professional bodies recognised by the State Government or Central Government as equivalent to above.
- Some Universities/Institutes/Examination Boards do not award Class or Percentage of marks and allot Aggregate Grade Points (e.g. CGPA/OGPA/CPI, etc.). In case University/Institute/Examination Board defines criteria for conversion of Aggregate Grade Point into Class and/or percentage of marks, the same shall be accepted. However, where the University/ Institute/ Examination does not define criteria for conversion of Aggregate Grade Point into Class and/or percentage of marks, the same shall be accepted. However, where the University/ Institute/ Examination does not define criteria for conversion of Aggregate Grade Point into Class and/or percentage of marks, the Aggregate Grade Points shall be multiplied by 10 to get the required percentage of marks.

B. Category - II Technician (Diploma) Apprentices:-

- A Diploma in Engineering or Technology granted by a State Council or Board of Technical Education established by a State Government in relevant discipline.
- A Diploma in Engineering or Technology granted by a University in relevant discipline.
- A Diploma in Engineering and Technology granted by an Institution recognised by the State Government or Central Government as equivalent to above.

C. Those candidates having qualifications equivalent to any of the prescribed qualifications should submit Equivalency Certificate issued by the competent authority and without such certificate, their candidature will not be considered.

- II. AGE: Above 18 years old as on 15.07.2025.
- III. <u>**RESERVATION OF VACANCIES:**</u> Government of India Directives on reservation applicable for Scheduled Caste (SC)/Scheduled Tribe (ST)/Other Backward Class (OBC) / Persons with Benchmark Disabilities (PwBD) will be strictly followed.
- IV. <u>MINIMUM PHYSICAL STANDARDS</u>: As prescribed in Clause 4 of the Apprenticeship Rule 1992, and amendments thereof if any.
- V. **<u>DURATION OF TRAINING</u>**: The duration of Apprenticeship training will be for a period of one year as per Apprentices (Amendment) Act 1973.
- VI. The applicant shall be an Indian citizen domiciled in Andaman & Nicobar Islands.
- VII. <u>PREVIOUS TRAINING</u>: Candidates who have already undergone or are currently undergoing apprenticeship under Apprentices (Amendment) Act 1973 in any Government or Public Sector or Private Organisation are **NOT ELIGIBLE to apply**.

VIII. SELECTION PROCEDURE:

- A. Only candidates who are domicile of Andaman & Nicobar Islands shall be considered. Short-listing of candidates for selection will be done based on the percentage of marks obtained in the basic prescribed qualification as applicable to the respective disciplines. In case, same percentage of marks is secured by more than one candidate in prescribed qualification, relative merit shall be decided based on seniority in passing year.
- **B.** Candidates short-listed for the certificate verification prior to selection should bring the original certificates towards proof of age, qualification, percentage of mark, caste, disability (if any) etc. and self-attested copies of all these certificates, for verification and their candidature shall be considered on the strength of the original certificates. In case of failure to produce the original certificates, the candidature shall be rejected.
- **C.** Those candidates who successfully complete certificate verification shall be provisionally considered for selection against the notified training seats in the order of merit/reservation, subject to medical fitness.
- IX. <u>**TRAVEL EXPENSES:**</u> No travel expenses are admissible during apprenticeship training period.
- X. **<u>BOARDING/LODGING:</u>** Boarding or lodging will not be provided by CSL during the apprenticeship training period.
